



**UNSW Global Pty Limited (ABN 62 086 418 582)**  
**2017 UNSW Careers Expo – Wednesday, 26 July, 2017**  
**Terms and Conditions**

1. UNSW Global Pty Limited (ABN 62 086 418 582) of 12-22 Rothschild Avenue, Rosebery NSW 2018 (**UNSW Global**) is conducting a competition at the 2017 UNSW Careers Expo (**Expo**) to promote the language teaching services of the UNSW Institute of Languages (**UNSWIL**), a business of UNSW Global (**Expo Competition**).
2. Entries will be accepted from 9am to 5pm on 26 July 2017 (**Expo Competition Period**), at The John Niland Scientia Building, UNSW, Botany Street, Kensington NSW 2033.
3. Any person who is eligible to attend the Expo, who is over 18 years of age, may enter the Expo Competition by including their name, email address and phone number on an iPad list of entrants maintained by UNSW Global representatives at the UNSW Global stall at the Expo (**Expo Competition List**) during the Expo Competition Period. Entry into the Expo Competition is free and there can only be one entry per person. By entering the Expo Competition in this way, entrants agree to be bound by these terms and conditions. [**Note: this statement will appear prominently on the Expo Competition List, together with directions on where to find the full terms and conditions on UNSW Global's Facebook page**].
4. On 2 August 2017, on or around 10:00am (**Draw Date**), UNSW Global will, at its premises, randomly select one entrant from the Expo Competition List (**Winner**). Within two days of the Draw Date, UNSW Global will email and text the Winner using the contact details they provided on the Expo Competition List to inform them of their win (**Notification Email** and **Notification Text**). For the purposes of the law in relation to privacy and spam, entrants consent to UNSW Global collecting, storing, using and disclosing their personal information for the purposes of the Expo Competition (including contacting the Winner). [**Note: an unsubscribe facility will be included in the Notification Email and Notification Text**].
5. UNSW Global will also publish the Winner's name on its Facebook page within two days of the Draw Date. By entering the Expo Competition, entrants consent to such publication.
6. The Winner will be entitled to enrol in one 10 week non-English language course offered by UNSWIL at its premises at 223 Anzac Parade, Kensington NSW 2033 with a course completion date on or prior to 31 December 2017, valued at A\$380 (**Prize**). Each of the Notification Email and Notification Text will contain the contact details of a representative of UNSW Global so that the Winner can get in touch to enrol in their course. The Prize is not redeemable for cash or an alternative prize.
7. In the event that, for whatever reason, a Prize is unavailable, UNSW Global may substitute a prize of equivalent value, subject to any direction from Liquor & Gaming NSW or other relevant regulatory authority (**Relevant Authority**).
8. Should the Winner not wish to take up their Prize, they may nominate another recipient in writing to UNSW Global but must do so on or prior to 2 November 2017 (**Redraw Date**) and provided this person is over 18.
9. If the Winner:
  - (a) does not respond to either UNSW Global's Notification Email or Notification Text; and
  - (b) has not otherwise communicated to UNSW Global for the purpose of taking up their Prize,by the Redraw Date (**Non-responding Winner**), UNSW Global will conduct a redraw in the same manner as the original draw (except the Non-responding Winner will be excluded from the



Expo Competition List) and subject to any direction from a Relevant Authority. The Non-responding Winner will have no entitlement to a Prize in this case.

10. Incomplete entries will be deemed invalid and excluded from the Competition.
11. UNSW Global's decisions with respect to the Expo Competition are final and it will not engage in any correspondence with any person in relation to these decisions.
12. Staff of UNSW Global and their immediate family members are ineligible to enter.
13. If, for reasons beyond UNSW Global's reasonable control, the Expo Competition is not capable of being conducted in the manner contemplated by UNSW Global, it may (unless to do so is prohibited by law) cancel, suspend, modify or terminate the Expo Competition.
14. UNSW Global excludes from these terms and conditions all conditions, warranties and terms implied by statute, the general law or custom (other than those terms the exclusion of which would render all or part of these terms void). To the maximum extent permitted by law, UNSW Global (including its officers, employees, contractors and agents) excludes all liability, whether direct or indirect, for loss or damage arising in any way as a result of the Expo Competition. This includes any loss associated with a Prize or use of a Prize.
15. This is a game of chance under the *Lotteries and Art Unions Act 1901* (NSW) (permit number [LTPS/17/15679]).
