1. Attendees who provide their contact details will go into the draw to win a prize.

Entries (in the form of a business card) will be accepted from Conference attendees aged 18 and over from 8.00am to 4.00pm on 13 June 2017 and from 8.00am to 3.30pm on 14 June 2017 (**Conference Competition Period**), at the box marked "Conference Competition" (**Box**) located at UNSW Global Stand 45 at the Sofitel Wentworth Sydney, 61 – 101 Phillip Street, Sydney NSW 2000 (**Conference Venue**). Entry is free and there can only be one entry per person. By entering the Conference Competition in this way, entrants agree to be bound by these terms and conditions.
3. On 14 June 2017 (**Draw Date**), on or around 3.30pm, 3.35pm and 3.40pm, UNSW Global will randomly select one entrant from the Box (**Winners**). The entrant drawn at 3.30pm will receive the first prize, the entrant drawn at 3.35pm will receive the second prize and the entrant drawn at 3.40pm will receive the third prize.
